



NATIONAL BANK OF ETHIOPIA INVITATION FOR PREQUALIFICATION OF DESIGN-BUILD PRIME CONTRACTOR

Project Name: National Bank of Ethiopia Branch Office Building Design-Build Project

1. The **National Bank of Ethiopia** invites interested Design-build Contractors to prequalify for five similar branch building contracts as one package each having 1B+G+M+6+Mechanical Story Building. Each main building will have an average gross area of about 20,000m². The Bank will provide a preliminary schematic architectural design drawing and site plan & information to be used as a startup for the Design-Build [DB] contractor.
2. Prequalification will be conducted through the procedures as specified in the Prequalification Document and it is open to all eligible applicants.
3. A shortlist of prequalified applicants will be invited to participate in an International Competitive Tender. At the time of invitation for tender, prequalified applicants shall be given a list of named subcontractors priority shortlisted by the Bank for the cash center technology and related security systems. Tenderers shall provide their technical and financial bid offer including and integrating with the named subcontractor they have chosen from the list. The winner of the Tender will be required to have a sub-contracting agreement with the named (short listed) sub-contractor.
4. Interested eligible applicants should have proven experience and best performance reputations in delivery of design-build projects similar to this project in size and complexity. Applicants may obtain further information from National Bank of Ethiopia, at the address below under 7 during office hours (8:00 AM-12:00 PM & 1:00 PM - 5:00 PM, Monday to Friday) local time at Addis Ababa, Ethiopia.
5. A Complete set of prequalification documents prepared in **English** shall be purchased by interested applicants on the submission of a written application to the address below 7. Upon payment of a non-refundable fee of Ethiopian Birr (ETB) 1,000.00 (One Thousand Birr only) or United States Dollar (USD) \$100.00 (One Hundred United States Dollar), the Bank will provide the hard copy of the prequalification document and send it to the applicant's e-mail mentioned on the application letter.

The method of payment will be in a Bank transfers through the Bank's SWIFT address NBETETAA for Applicants from abroad Or by depositing to the account No. 7002010800001 at Payment and Settlement Systems Directorate found in NBE New Building, during office hours (Monday to Friday) 8:00-12:00 p.m. And 1:00-5:00 PM).

Applications for prequalification should be submitted in sealed envelopes, delivered to the address below at 7 along with one (1) original set, one softcopy in a CD (in pdf format) and one (1) copy set of Prequalification Documents, having been signed on each page by authorized personnel on or before 17th February 2021 at 10:00 Am in the morning. The Applications will be opened on 17th February 2021 at 10:00 Am in the morning at the Procurement Services Management Directorate Office of National Bank of Ethiopia.
